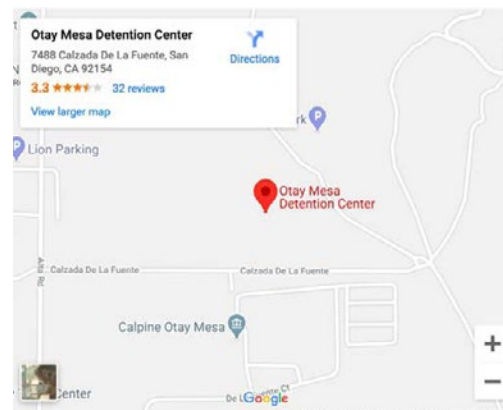

Visitation hours:

Otay Mesa Detention Facility has both in person and video visitation hours for the families who have a loved one who is being detained in the facility. Video visitation can occur between 8:30 AM and 7:00 PM and is available 7 days a week. In person visitation occurs on Saturday, Sunday and Holidays between 9:00 AM and 8:00 PM. You must schedule an appointment for visitation 10 days in advance by sending an email to OMDCvisits@cca.com.

Immigration Bond Information for the Otay Mesa Detention Center

Delivery bonds (i.e., immigration bonds) cannot be posted in-person directly at the Adelanto ICE Processing Center. Instead, family members or associates can post an immigration bond at any of the 82 ICE-ERO facilities around the country that accept immigration bonds. The closest facility to the Adelanto ICE Processing Center that accepts immigration bonds is located at 300 N Los Angeles Street, Suite 7621, Los Angeles, CA 90012. Immigration bonds can be posted Monday-Friday (except holidays) at this facility from 9:00 AM to 3:00 PM. Bonds cannot be posted directly at the Adelanto ICE Processing Center.

To post an immigration bond for someone detained at this facility, you must have a money order, cashier's check or certified check. If the bond amount exceeds \$10,000 and over, you can only pay by single cashier's check or a certified check. All payments should be made to the "US Department of Homeland Security" or "Immigration and Customs Enforcement."

If you do not want to post the bond in-person yourself, you can also have a licensed immigration bond agent post the bond for you. For a small fee, ranging from 2% – 10%, an agent can post the bond for you electronically, so that you do not have to travel to the ICE ERO facility. This process is typically faster and easier than posting a bond yourself.

- Last name (including hyphenated last names)
- Any aliases the detainee might use
- Date of birth
- Country of birth

Please have the following detainee information available:

- Full name
- Alien Registration Number (A Number)
- Your name and telephone number

Frequently asked questions about the Otay Mesa Detention Center

Does the facility have public parking?

Yes, there is free public parking available at the Otay Mesa Detention Facility.

Can I post a bond for someone who is detained at this facility?

No. The Otay Mesa Detention Facility does not accept immigration bonds at that facility. If you would like to post an immigration bond for someone being detained at the Otay Mesa Detention Facility, you must post one in person at one of the 82 ICE-ERO offices around the country. The closest ICE-ERO office to the Otay Mesa Detention Facility is located at 880 Front Street, San Diego, CA 92101. The phone number for that office is 619.436.0084.

How do Consular visits work at this center?

Consular officials can meet with their detained nationals at any time. The facility requests that all arrangements be made with the ICE Supervisory Deportation Officer first. All Consular representatives must bring appropriate identification and credentials. To speak with the ICE Supervisory Deportation Officer call 619.661.3824.

California ICE Detention Facilities

Not every ICE detention facility allows you to post an immigration bond in California. If you would like to post an immigration bond it must be done at an ICE-ERO facility that accepts immigration bonds.

There are 7 ICE detention facilities in California. They are as follows:

- Adelanto ICE Processing Center
- Santa Ana City Jail
- Yuba County Jail
- Mesa Verde ICE Processing Facility
- James A. Musick Facility
- Imperial Regional Detention Facility
- Otay Mesa Detention Center

If you need an easier way to post an immigration bond for someone who is detained at an immigration detention facility in California, **you can post an immigration bond through a licensed immigration bonding agent by calling (844) 910-2342.** That agent can post a bond for you electronically for any detention facility in California and around the US.
