Visitation Hours: The Aurora Contract Detention Facility has varying hours for visitation based on the housing unit that each detainee is assigned. Call the facility at 303.361.6612 to find out which housing unit your family member is assigned to. Below is a schedule:

- A Unit -Tuesday, Friday Saturday from 7:00 AM to 1:00 PM
- B1 and B2 Units Monday, Thursday and Sunday from 7:00AM to 1:00PM
- B3 & B4 Units Tuesday, Thursday, Sunday from 3:00 PM 9:00 PM
- D Unit (Females) Monday & Wednesday from 3:00 PM 6:00 PM and Saturday from 6:00 PM – 10:00 PM
- SHU- Wednesday from 7:00 AM 9:00 AM and Friday & Saturday from 1:30 PM – 3:30 PM

You should plan on arriving at least 45 minutes before the scheduled visitation time so you can be processed appropriately through security. All visitors must show a valid ID and visits are not to exceed one hour. Attorneys are allowed to visit their clients from 8:00 AM to 9:00 PM daily, including Holidays.

Immigration Bond Information for the Etowah County Detention Center

Delivery bonds (i.e., immigration bonds) cannot be posted in-person directly at the Aurora Contract Detention Facility. Instead, family members or associates can post an immigration bond at any of the 82 ICE-ERO facilities around the country that accept immigration bonds. The closest facility to the Aurora Contract Detention Facility that accepts immigration bonds is located at Denver Contract and Detention Facility (GEO) located at 3130 N. Oakland Street, Aurora, CO 80010. Immigration bonds can be posted Monday-Friday (except holidays) at this facility from 9:00 AM to 3:00 PM. Bonds cannot be posted directly at the Aurora Contract Detention Facility.

To post an immigration bond for someone detained at this facility, you must have a money order, cashier's check or certified check. If the bond amount exceeds \$10,000 and over, you can only pay by single cashier's check or a certified check. All payments should be made to the "US Department of Homeland Security" or "Immigration and Customs Enforcement."

If you do not want to post the bond in-person yourself, you can also have a licensed immigration bond agent post the bond for you. For a small fee, ranging from 2% - 10%, an agent can post the bond for you electronically, so that you do not have to travel to the ICE-ERO facility. This process is typically faster and easier than posting a bond yourself.

Frequently asked questions about the Aurora Contract Detention Facility

Does the facility have public parking?

Yes. If you know someone who is detained at the Aurora Contract Detention Facility in Aurora, Colorado and you would like to visit them, there is public parking available the facility as well as on the street.

Can I post a bond for someone who is detained at this facility?

If an immigration judge has set a bond in the immigrant's case, then yes, you may bond someone out who is being detained at this facility. See the next question below, regarding the various locations where bonds can be processed.

If I am bonding someone out of this facility, do I post the bond there or another location?

While you can bail someone out of the Aurora Contract Detention Facility, you cannot post the bond at that facility. The immigration bond must be posted at one of 82 ICE-ERO facilities that accept immigration bonds. The closest ICE-ERO facility near the Aurora Contract Detention Facility is the Denver Contract and Detention Facility (GEO) located at 3130 N. Oakland Street, Aurora, CO 80010 (303) 361-0723.

Colorado ICE Detention Facilities

Not every ICE detention facility allows you to post an immigration bond. If you would like to post an immigration bond it must be done at an ICE-ERO facility that accepts immigration bonds.

There are 3 ICE detention facilities in Colorado. They are as follows:

- Aurora Contract Detention Facility
- Teller County Detention Center
- El Paso County Criminal Justice Center

If you need an easier way to post an immigration bond for someone who is detained at an immigration detention facility, **you can post an immigration bond through a licensed immigration bonding agent by calling (844) 910-2342**. That agent can post a bond for you electronically for any detention facility in the US.
