Visitation hours:

The three rotating time slots available are Monday – Sunday at:

8:00 AM – 10:00 AM
12:00 PM – 4:00 PM
6:30 PM – 8:30 PM

Visitation Rules:

Visitors are advised to contact the detainee to determine the appropriate time slot. All visitors must have a valid ID to enter the facility and all minors must be accompanied by an adult. Visits are limited to two hours. It is recommended that visitors show up at least 15 minutes prior to the visitation hours to allow time for processing. Attorneys are allowed to visit their clients daily from 7:00 AM to 10:00 PM.

Immigration Bond Information for the Glades County Detention Center?

Delivery bonds (i.e., immigration bonds) cannot be posted in-person directly at the Glades County Detention Center. Instead, family members or associates can post an immigration bond at any of the 82 ICE-ERO facilities around the country that accept immigration bonds. The closest facility to the Glades County Detention Center that accepts immigration bonds is located at 5524 West Cypress Street, Tampa, FL 33607. Immigration bonds can be posted Monday-Friday (except holidays) at this facility from 9:00 AM to 3:00 PM. Bonds cannot be posted directly at the Glades County Detention Center.

To post an immigration bond for someone detained at this facility you must have a money order, cashier's check or certified check. If the bond amount exceeds \$10,000 and over, you can only pay by single cashier's check or a certified check. All payments should be made to the "US Department of Homeland Security" or "Immigration and Customs Enforcement."

If you do not want to post the bond in-person yourself, you can also have a licensed immigration bond agent post the bond for you. For a small fee, ranging from 2% – 10%, an agent can post the bond for you electronically, so that you do not have to travel to the ICE ERO facility. This process is typically faster and easier than posting a bond yourself.

- Any aliases the detainee might use
- Date of birth
- Country of birth

- Full name
- Alien Registration Number (A Number)
- Your name and telephone number

Frequently asked questions about the Glades County Detention Center

Does the facility have public parking?

Yes. there is public parking available in the front of the facility.

Can I post a bond for someone who is detained at this facility?

It really depends on the specific details of the case surround the immigrant/alien that you are looking to bond out. If an immigration judge has set a bond in the immigrant's case, then yes, you may bond someone out from this facility. See the next question below, regarding the various locations where bonds can be processed.

If I am bonding someone out of this facility, do I post the bond there or another location?

All bonds posted for any alien detained may be posted at any Immigration Customs Enforcement (ICE) Enforcement and Removal Operations (ERO) bond acceptance offices around the country between the hours of 9:00 am and 3:00 PM (except public holidays) local time. There are 82 ICE ERO offices where bonds can be posted (8 locations in California).

Florida ICE Detention Facilities

Not every ICE detention facility allows you to post an immigration bond in Florida. If you would like to post an immigration bond it must be done at an ICE-ERO facility that accepts immigration bonds.

There are 5 ICE detention facilities in Florida. They are as follows:

- Baker County Facility
- Broward Transitional Center
- Glades County Detention Center
- Krome Service Processing Center
- Wakulla County Facility

If you need an easier way to post an immigration bond for someone who is detained at an immigration detention facility, **you can post an immigration bond through a licensed immigration bonding agent by calling (844) 910-2342**. That agent can post a bond for you electronically for any detention facility in the US.
