

Immigration Bond Information for the Natchitoches Parish Detention Center

Delivery bonds (i.e., immigration bonds) cannot be posted in-person directly at the Natchitoches Parish Detention Center. Instead, family members or associates can post an immigration bond at any of the 82 ICE-ERO facilities around the country that accept immigration bonds. The closest facility to the Natchitoches Parish Detention Center that accepts immigration bonds is located at 1010 East Whatley Road, Oakdale, LA 71463. Immigration bonds can be posted Monday-Friday (except holidays) at this facility from 9:00 AM to 3:00 PM. Bonds cannot be posted directly at this Center.

To post an immigration bond for someone detained at this facility you must have a money order, cashier's check or certified check. If the bond amount exceeds \$10,000 and over, you can only pay by single cashier's check or a certified check. All payments should be made to the "US Department of Homeland Security" or "Immigration and Customs Enforcement."

If you do not want to post the bond in-person yourself, you can also have a licensed immigration bond agent post the bond for you. For a small fee, ranging from 2% - 10%, an agent can post the bond for you electronically, so that you do not have to travel to the ICE ERO facility. This process is typically faster and easier than posting a bond yourself.

- Last name (including hyphenated last names)
- Any aliases the detainee might use
- Date of birth
- Country of birth

Please have the following detainee information available:

- Full name
- Alien Registration Number (A Number)
- Your name and telephone number

Frequently asked questions about the Natchitoches Parish Detention Center

Does the facility have public parking?

Yes. If you know someone who is detained at Natchitoches Parish Detention Center in Natchitoches, Louisiana and you would like to visit them, there is designated visitor parking.

Can I post a bond for someone who is detained at this facility?

If an immigration judge has set a bond in the immigrant's case, then yes, you may bond someone out of this facility. See the next question below, regarding the various locations where bonds can physically be posted and processed.

If I am bonding someone out of this facility, do I post the bond there or another location?

While you can bail someone out of the Natchitoches Parish Detention Center, you cannot post the bond at that facility. The immigration bond must be posted at one of 82 ICE-ERO facilities that accept immigration bonds. The closes ICE-ERO facility near the Natchitoches Parish Detention Center is located at 1010 East Whatley Road, Oakdale, LA 71463. The phone number for that facility is (318) 335-7500.

Louisiana ICE Detention Facilities

There are nine immigration detention facility in Louisiana.

Not every detention facility allows you to post an immigration bond in Louisiana. If you would like to post an immigration bond in Louisiana it must be done at an ICE-ERO facility that accepts immigration bonds. In Louisiana there are two ICE-ERO facilities where you can post an immigration bond in person. These facilities are at:

If you need an easier way to post an immigration bond for someone who is detained at an immigration detention facility, **you can post an immigration bond through a licensed immigration bonding agent by calling (844) 910-2342**. That agent can post a bond for you electronically for any detention facility in the US.
