Visitation hours at the Pine Prairie ICE Processing Center are organized by risk classifications. They are broken out as follows:

ICE Level Medium High & High Detainees

• Saturday 1:00 PM - 3:00 PM • Sunday 1:00 PM - 3:00 PM

ICE Level Low & Medium Low Detainees


• Saturday 3:00 PM - 5:00 PM • Sunday 3:00 PM - 5:00 PM

ICE Level Medium High & High Detainees

Saturday 5:00 PM – 6:00 PM
Sunday 5:00 PM – 6:00 PM

Weekday visits are available Monday-Friday 9:00~AM-3:00~PM and can be arranged through the warden.

The facility recommends you arrive at least 45 minutes ahead of your scheduled time so you can be processed appropriate through security. All visitors must be prepared to show a valid ID and visits are not to exceed 60 minutes unless prior approval from the warden. Attorneys can visit clients 7 days a week from 8AM-4:30 PM (including holidays)

Immigration Bond Information for the Pine Prairie ICE Processing Center

Delivery bonds (i.e., immigration bonds) cannot be posted in-person directly at the Pine Prairie ICE Processing Center. Instead, family members or associates can post an immigration bond at any of the 82 ICE-ERO facilities around the country that accept immigration bonds. The closest facility to the Pine Prairie ICE Processing Center that accepts immigration bonds is located at 1010 East Whatley Road, Oakdale, LA 71463. Immigration bonds can be posted Monday-Friday (except holidays) at this facility from 9:00 AM to 3:00 PM.

To post an immigration bond for someone detained at this facility you must have a money order, cashier's check or certified check. If the bond amount exceeds \$10,000 and over, you can only pay by single cashier's check or a certified check. All payments should be made to the "US Department of Homeland Security" or "Immigration and Customs Enforcement."

If you do not want to post the bond in-person yourself, you can also have a licensed immigration bond agent post the bond for you. For a small fee, ranging from 2% - 10%, an agent can post the bond for you electronically, so that you do not have to travel to the ICE ERO facility. This process is typically faster and easier than posting a bond yourself.

Frequently asked questions about the Pine Prairie ICE Processing Center

Does the facility have public parking?

Yes. If you know someone who is detained at Pine Prairie ICE Processing Center in Prairie, Louisiana and you would like to visit them, there is free parking in front the facility. Visitor parking is marked

Can I post a bond for someone who is detained at this facility?

If an immigration judge has set a bond in the immigrant's case, then yes, you may bond someone out of this facility. See the next question below, regarding the various locations where bonds can physically be posted and processed.

If I am bonding someone out of this facility, do I post the bond there or another location?

While you can bail someone out of the Pine Prairie ICE Processing Center, you cannot post the bond at that facility. The immigration bond must be posted at one of 82 ICE-ERO facilities that accept immigration bonds. The closes ICE-ERO facility near the Pine Prairie ICE Processing Center is located at 1010 East Whatley Road, Oakdale, LA 71463. The phone number for that facility is (318) 335-7500.

Not every detention facility allows you to post an immigration bond in Louisiana. If you would like to post an immigration bond in Louisiana it must be done at an ICE-ERO facility that accepts immigration bonds. In Louisiana there are two ICE-ERO facilities where you can post an immigration bond in person. These facilities are at:

If you need an easier way to post an immigration bond for someone who is detained at an immigration detention facility, you can post an immigration bond through a licensed immigration bonding agent by calling (844) 910-2342. That agent can post a bond for you electronically for any detention facility in the US.
