The visitation hours for the Howard County Detention Center are organized by the detainees' risk level. The visitation hours are broken out as follows:

ICE Level Medium High & High Detainees Tuesday 6:00 PM – 9:00 PM Thursday 6:00 PM – 9:00 PM Saturday 6:00 PM – 9:00 PM

ICE Level Low & Medium Low Detainees Tuesday 6:00 PM – 9:00 PM Thursday 6:00 PM – 9:00 PM Saturday 6:00 PM – 9:00 PM

ICE Restricted Housing Unit Detainees Tuesday 6:00 PM – 9:00 PM Thursday 6:00 PM – 9:00 PM Saturday 6:00 PM – 9:00 PM You should always plan on arriving at least 45 minutes before the scheduled visitation time so you can be processed appropriately through security. All visitors must show a valid ID and visits are not to exceed 60 minutes. Longer periods of visitation may be available for families traveling long distances.

Attorneys are allowed to visit their clients 24 hours a day, seven days a week.

## **Immigration Bond Information for the Howard County Detention Center**

Delivery bonds (i.e., immigration bonds) cannot be posted in-person directly at the Howard County Detention Center. Instead, family members or associates can post an immigration bond at any of the 82 ICE-ERO facilities around the country that accept immigration bonds. The closest facility to the Howard County Detention Center that accepts immigration bonds is located at 31 Hopkins Plaza, Baltimore, MD 21201. Immigration bonds can be posted Monday-Friday (except holidays) at this facility from 9:00 AM to 3:00 PM. Bonds cannot be posted directly at the Howard County Detention Center.

To post an immigration bond for someone detained at this facility you must have a money order, cashier's check or certified check. If the bond amount exceeds \$10,000 and over, you can only pay by single cashier's check or a certified check. All payments should be made to the "US Department of Homeland Security" or "Immigration and Customs Enforcement."

If you do not want to post the bond in-person yourself, you can also have a licensed immigration bond agent post the bond for you. For a small fee, ranging from 2% - 10%, an agent can post the bond for you electronically, so that you do not have to travel to the ICE ERO facility. This process is typically faster and easier than posting a bond yourself.

- Any aliases the detainee might use
- Date of birth
- Country of birth

- Full name
- Alien Registration Number (A Number)
- Your name and telephone number

## Frequently asked questions about the Howard County Detention Center

#### Does the facility have public parking?

Yes. If you know someone who is detained at the Howard Detention Center in Jessup, Maryland and you would like to visit them, there is free public parking available at the facility. Visitor parking is marked.

#### Can I post a bond for someone who is detained at this facility?

If an immigration judge has set a bond in the immigrant's case, then yes, you may bond someone out of this facility. See the next question below, regarding the various locations where bonds can physically be posted and processed.

#### If I am bonding someone out of this facility, do I post the bond there or another location?

While you can bail someone out of the Howard County Detention Center, you cannot post the bond at that facility. The immigration bond must be posted at one of 82 ICE-ERO facilities that accept immigration bonds. The closest ICE-ERO facility near the Howard County Detention Center is located at 31 Hopkins Plaza, Baltimore, MD 21201 (410) 637-4000.

## **Maryland ICE Detention Facilities**

There are three ICE Immigration detention facilities in Maryland. This includes:

- Worcester County Detention Center
- Frederick County Detention Center
- Howard County Detention Center

Not every detention facility allows you to post an immigration bond in Maryland. If you would like to post an immigration bond it must be done at an ICE-ERO facility that accepts immigration bonds. In Maryland there are two ICE-ERO Facilities where you can post an immigration bond in person. These facilities are located at the following addresses:

If you need an easier way to post an immigration bond for someone who is detained at an immigration detention facility, **you can post an immigration bond through a licensed immigration bonding agent by calling (844) 910-2342**. That agent can post a bond for you electronically for any detention facility in the US.
