Immigration Bond Information for the Dodge Detention Facility

Delivery bonds (i.e., immigration bonds) cannot be posted in-person directly at the Dodge Detention Facility. Instead, family members or associates can post an immigration bond at any of the 82 ICE-ERO facilities around the country that accept immigration bonds. The closest facility to the Dodge Detention Facility that accepts immigration bonds is located at 310 East Knapp Street, Milwaukee, WI 53202. The number there is (414) 287-6351. Immigration bonds can be posted Monday-Friday (except holidays) at this facility from 9:00 AM to 3:00 PM. Bonds cannot be posted directly at the Dodge Detention Facility.

To post an immigration bond for someone detained at this facility you must have a money order, cashier's check or certified check. If the bond amount exceeds \$10,000 and over, you can only pay by single cashier's check or a certified check. All payments should be made to the "US Department of Homeland Security" or "Immigration and Customs Enforcement."

If you do not want to post the bond in-person yourself, you can also have a licensed immigration bond agent post the bond for you. For a small fee, ranging from 2% - 10%, an agent can post the bond for you electronically, so that you do not have to travel to the ICE ERO facility. This process is typically faster and easier than posting a bond yourself.

Frequently asked questions about the Dodge Detention Facility

Does the facility have public parking?

Yes. If you know someone who is detained at the Dodge Detention Facility in Juneau, Wisconsin and you would like to visit them, there is public parking available across from the facility.

Can I post a bond for someone who is detained at this facility?

If an immigration judge has set a bond in the immigrant's case, then yes, you may bond someone out of this facility. See the next question below, regarding the various locations where bonds can physically be posted and processed.

If I am bonding someone out of this facility, do I post the bond there or another location?

While you can bail someone out of the Dodge Detention Facility, you cannot post the bond at that facility. The immigration bond must be posted at one of 82 ICE-ERO facilities that accept immigration bonds. The closest ICE-ERO facility near the Dodge Detention Facility is located at 310 East Knapp Street, Milwaukee, WI 53202. The number there is (414) 287-6351.

Wisconsin ICE Detention Facilities

There are two Immigration Detention Facilities in Wisconsin. This includes:

- Dodge Detention Facility
- Kenosha County Detention Center

Not every detention facility allows you to post an immigration bond in Wisconsin. If you would like to post an immigration bond it must be done at an ICE-ERO facility that accepts immigration bonds. In Wisconsin there is one ICE-ERO Facility where you can post an immigration bond in person. This facility is located at the following address:

If you need an easier way to post an immigration bond for someone who is detained at an immigration detention facility, **you can post an immigration bond through a licensed immigration bonding agent by calling (844) 910-2342**.
