



Visitation hours at the East Hidalgo Detention Center are broken out as follows:

Monday, Wednesday, Friday and Sunday 3:15 PM – 6:00 PM

All visits are not to exceed 30 minutes. The facility recommends you arrive at least 45 minutes ahead of your scheduled time so you can be processed appropriate through security. All adults must present a valid ID. Attorneys can visit clients Daily from 8:00 AM – 10:00 PM.

### Immigration Bond Information for the East Hidalgo Detention Center

Delivery bonds (i.e., immigration bonds) cannot be posted in-person directly at the East Hidalgo Detention Center. Instead, family members or associates can post an immigration bond at any of the 82 ICE-ERO facilities around the country that accept immigration bonds. The closest facility to the East Hidalgo Detention Center that accepts immigration bonds is located at 1717 Zoy Street, Harlingen, TX 78550. The number there is (956) 389-7800. Immigration bonds can be posted Monday-Friday (except holidays) at this facility from 9:00 AM to 3:00 PM. Bonds cannot be posted directly at the East Hidalgo Detention Center.

To post an immigration bond for someone detained at this facility you must have a money order, cashier's check or certified check. If the bond amount exceeds \$10,000 and over, you can only pay by single cashier's check or a certified check. All payments should be made to the "US Department of Homeland Security" or "Immigration and Customs Enforcement."

If you do not want to post the bond in-person yourself, you can also have a licensed immigration bond agent post the bond for you. For a small fee, ranging from 2% - 10%, an agent can post the bond for you electronically, so that you do not have to travel to the ICE ERO facility. This process is typically faster and easier than posting a bond yourself.

To search for a detainee, visit www.cfiaus.com and have the detainee's first and last name the detainee's country of birth. You can also call ICE directly with the information below.

#### How to get information on an ICE detainee

Please call the Field Office Main Telephone Number, (210) 283-4750. Please have the following detainee information available:

- First name
- Last name (including hyphenated last names)
- Any aliases the detainee might use
- Date of birth
- Country of birth

#### How to get in touch with an ICE detainee

Please have the following detainee information available:

- Full name
- Alien Registration Number (A Number)
- Your name and telephone number

### Frequently asked questions about the East Hidalgo Detention Center

#### Does the facility have public parking?

Yes. If you know someone who is detained at East Hidalgo Detention Center in La Villa, Texas and you would like to visit them, there is free parking available at the facility.

#### Can I post a bond for someone who is detained at this facility?

If an immigration judge has set a bond in the immigrant's case, then yes, you may bond someone out of this facility. See the next question below, regarding the various locations where bonds can physically be posted and processed.

#### If I am bonding someone out of this facility, do I post the bond there or another location?

While you can bail someone out of the East Hidalgo Detention Center, you cannot post the bond at that facility. The immigration bond must be posted at one of 82 ICE-ERO facilities that accept immigration bonds. The closest facility to the East Hidalgo Detention Center that accepts immigration bonds is located at 1717 Zoy Street, Harlingen, TX 78550. The number there is (956) 389-7800.
