

**Hours of Operation**: There are four different immigration detention housing units located at the Etowah County Detention Center. There hours of visitation are as follows:

- Unit 1: Sunday & Monday, 9AM-1PM; Tuesday & Wednesday, 2PM-5PM
- Unit 8: Sunday & Monday, 9AM-1PM; Tuesday & Wednesday, 2PM-5PM
- Unit 9: Sunday & Monday, 2PM-5PM; Tuesday & Wednesday, 9AM-1PM
- Unit 10: Sunday & Monday, 2PM-5PM; Tuesday & Wednesday, 9AM-1PM

#### **Visitation Rules:**

- The facility recommends you arrive at least 45 minutes ahead of your scheduled time so you can be processed appropriate through security.
- All visitors must show a valid ID and visits are not to exceed 30 minutes.
- Attorney's are allowed to visit their clients from 8:00 AM to 7:00 PM daily (including holidays).
- Clergy may visit detainees at any time, but visits must be scheduled beforehand with the Chaplain's office at 256.549.2194.

## **Immigration Bond Information for the Etowah County Detention Center**

Delivery bonds (i.e., immigration bonds) cannot be posted in-person directly at this center. Instead, family members or associates can post an immigration bond at any of the 82 ICE-ERO facilities around the country that accept immigration bonds. The closest facility to the Etowah County Detention Center that accepts immigration bonds is located 180 Ted Turner Drive SW, 3rd Floor, Rm 337 Atlanta, GA 30303. Immigration bonds can be posted Monday-Friday (except holidays) at this facility from 9:00 AM to 3:00 PM. Bonds cannot be posted directly at the Etowah County Detention Center.

To post an immigration bond for someone detained at this facility, you must have a money order, cashier's check or certified check. If the bond amount exceeds \$10,000 and over, you can only pay by single cashier's check or a certified check. All payments should be made to the "US Department of Homeland Security" or "Immigration and Customs Enforcement."

If you do not want to post the bond in-person yourself, you can also have a licensed immigration bond agent post the bond for you. For a small fee, ranging from 2% - 10%, an agent can post the bond for you electronically, so that you do not have to travel to the ICE-ERO facility. This process is typically faster and easier than posting a bond yourself.

## Frequently asked questions about the Etowah County Detention Center

## Does the facility have public parking?

Yes. If you know someone who is detained at the Etowah County Detention Center in Gadsden, Alabama and you would like to visit them, there is free public parking available. The parking will be designated for visitors.

## Can I post a bond for someone who is detained at this facility?

If an immigration judge has set a bond in the immigrant's case, then yes, you may bond someone out who is being detained at this facility. See the next question below, regarding the various locations where bonds can be processed.

## If I am bonding someone out of this facility, do I post the bond there or another location?

While you can bail someone out of this facility, you cannot post the bond there. The immigration bond must be posted at one of 82 ICE-ERO facilities that accept immigration bonds. The closest ICE-ERO facility is located at 180 Ted Turner Drive SW, 3rd Floor, Rm 337 Atlanta, GA 30303. The phone number for that facility is (404) 893-1224.

## What is the easiest way to bond an ailen/immigrant out of this facility?

There are two ways to bond an alien/immigrant out of this facility. First, one can show up at one of the 82 ICE ERO bond accepting offices in person during business hours. Second, someone can utilize the services of a bonding agent who is able to post the bond electronically so that family members do not have to go to one of these ICE ERO locations in person. Additionally, when a family uses the services of a bonding agent the detained individual will be released much sooner.

If you need an easier way to post an immigration bond for someone who is detained at an immigration detention facility, you can post an immigration bond through a licensed immigration bonding agent by calling (844) 910-2342. That agent can post a bond for you electronically for any detention facility in the US.
