



Visitation Hours:

The hours of visitation for the Central Arizona Correctional Center are Monday and Wednesday 7:00 AM – 9:00 AM. Special visitation requests can be made through visitation request system.

You should always plan on arriving at least 45 minutes before the scheduled visitation time so you can be processed appropriately through security. All visitors must show a valid ID and visits are not to exceed two hours.

Attorneys are allowed to visit their clients from 8:00 AM to 8:00 PM daily. All attorney visits must be pre-scheduled 24 hours in advance.

Immigration Bond Information for the Central Arizona Correctional Center

Delivery bonds (i.e., immigration bonds) cannot be posted in-person directly at the Central Arizona Correctional Center. Instead, family members or associates can post an immigration bond at any of the 82 ICE-ERO facilities around the country that accept immigration bonds. The closest facility to the Central Arizona Correctional Center that accepts immigration bonds is located at 3250 North Pinal Parkway, Florence Arizona 85132. Immigration bonds can be posted Monday-Friday (except holidays) at this facility from 9:00 AM to 3:00 PM. Bonds cannot be posted directly at the Central Arizona Correctional Center.

To post an immigration bond for someone detained at this facility, you must have a money order, cashier's check or certified check. If the bond amount exceeds \$10,000 and over, you can only pay by single cashier's check or a certified check. All payments should be made to the "US Department of Homeland Security" or "Immigration and Customs Enforcement."

If you do not want to post the bond in-person yourself, you can also have a licensed immigration bond agent post the bond for you. For a small fee, ranging from 2% - 10%, an agent can post the bond for you electronically, so that you do not have to travel to the ICE-ERO facility. This process is typically faster and easier than posting a bond yourself.

- First name
- Last name (including hyphenated last names)
- Any aliases the detainee might use
- Date of birth
- Country of birth

How to get in touch with an ICE detainee

Please have the following detainee information available:

- Full name
- Alien Registration Number (A Number)
- Your name and telephone number



Frequently asked questions about the Central Arizona Correctional Center

Does the facility have public parking?

Yes. If you know someone who is detained at the Central Arizona Correctional Center in Florence, Arizona and you would like to visit them, there is public parking available in front of the facility.

Can I post a bond for someone who is detained at this facility?

If a bond has been set then yes, you may bond someone out who is being detained at this facility. See the next question below, regarding the various locations where bonds can be processed.

If I am bonding someone out of this facility, do I post the bond there or another location?

While you can bail someone out of the Central Arizona Correctional Center, you cannot post the bond at that facility. The immigration bond must be posted at one of 82 ICE-ERO facilities that accept immigration bonds. The closest ICE-ERO facility is located at 3250 North Pinal Parkway, Florence Arizona 85132. You may also contact that location by phone at (520) 868-5862.

Arizona ICE Detention Facilities

Not every ICE detention facility allows you to post an immigration bond. If you would like to post an immigration bond it must be done at an ICE-ERO facility that accepts immigration bonds.

There are 6 ICE detention facilities in Arizona. They are as follows:

- Central Arizona Correctional Center
- Eloy Detention Center
- Florence Correctional Center
- Florence Service Processing Center (SPC)
- Federal Bureau of Prisons (BoP) Federal Corrections Institute (FCI) Phoenix
- La Palma Correctional Center

If you need an easier way to post an immigration bond for someone who is detained at an immigration detention facility, you can post an immigration bond through a licensed immigration bonding agent by calling (844) 910-2342. That agent can post a bond for you electronically for any detention facility in the US.
