

Visitation Hours:

The Federal Bureau of Prisons Federal Corrections Institute Phoenix has consistent visiting hours Saturday, Sunday, Monday and Federal Holidays from 8:00 AM - 3:00 PM. Please note that visitors will not be allowed after 2:00 and all visitors must be pre-approved.

All visitors must show a valid ID and visits are not to exceed 4 hours. It is recommended that you arrive at least 60 minutes before you scheduled visit so that you can be signed in.

Immigration Bond Information for the Prisons Federal Corrections Institute Phoenix

Delivery bonds (i.e., immigration bonds) cannot be posted in-person directly at the Federal Bureau of Prisons Federal Corrections Institute Phoenix. Instead, family members or associates can post an immigration bond at any of the 82 ICE-ERO facilities around the country that accept immigration bonds. The closest facility to the Federal Bureau of Prisons Federal Corrections Institute Phoenix that accepts immigration bonds is located at 3250 North Pinal Parkway, Florence Arizona 85132. Immigration bonds can be posted Monday-Friday (except holidays) at this facility from 9:00 AM to 3:00 PM. Bonds cannot be posted directly at the Federal Bureau of Prisons Federal Corrections Institute Phoenix.

To post an immigration bond for someone detained at this facility, you must have a money order, cashier's check or certified check. If the bond amount exceeds \$10,000 and over, you can only pay by single cashier's check or a certified check. All payments should be made to the "US Department of Homeland Security" or "Immigration and Customs Enforcement."

If you do not want to post the bond in-person yourself, you can also have a licensed immigration bond agent post the bond for you. For a small fee, ranging from 2% - 10%, an agent can post the bond for you electronically, so that you do not have to travel to the ICE-ERO facility. This process is typically faster and easier than posting a bond yourself.

Frequently asked questions about the Prisons Federal Corrections Institute Phoenix

Does the facility have public parking?

Yes, there is public parking located at the facility. It is located in the left side or southern portion of the parking lot. All visitors will be provided parking.

Is this facility accessible for individuals with disabilities?

Yes, according with all state and federal laws, the Federal Bureau of Prisons Federal Corrections Institute Phoenix does not discriminate based on any disability.

If I am bonding someone out of this facility, do I post the bond there or another location?

While you can bail someone out of the Federal Bureau of Prisons Federal Corrections Institute Phoenix, you cannot post the bond at that facility. The immigration bond must be posted at one of 82 ICE-ERO facilities that accept immigration bonds. The closest ICE-ERO facility near the Federal Bureau of Prisons Federal Corrections Institute Phoenix is located at 2035 North Central Avenue, Phoenix Arizona 85004. You may also contact that location by phone at (602) 257-5900.

Arizona ICE Detention Facilities

Not every ICE detention facility allows you to post an immigration bond. If you would like to post an immigration bond it must be done at an ICE-ERO facility that accepts immigration bonds.

There are 6 ICE detention facilities in Arizona. They are as follows:

- Central Arizona Correctional Center
- Eloy Detention Center
- Florence Correctional Center
- Florence Service Processing Center (SPC)
- Federal Bureau of Prisons (BoP) Federal Corrections Institute (FCI) Phoenix
- La Palma Correctional Center

If you need an easier way to post an immigration bond for someone who is detained at an immigration detention facility, **you can post an immigration bond through a licensed immigration bonding agent by calling (844) 910-2342**. That agent can post a bond for you electronically for any detention facility in the US.
