Visitation hours and policies:

For people wanting to visit the Mesa Verde ICE Processing Facility in Bakersfield, California, they must present a valid US ID. No more than three visitors per visit and visits must not exceed an hour.

Housing Unit A – Monday 1PM-9PM; Saturday 8AM-2PM
Housing Unit B – Tuesday 1PM-9:30PM; Saturday 2:30PM-10:30 PM
Housing Unit C – Thursday 1PM-9:30PM; Sunday 8AM-2PM
Housing Unit D – Friday 1PM-9:30PM; Sunday 2:30PM-10:30PM
Restricted Housing Unit – Wednesday 1PM-9:30PM; Saturday 7AM-8AM

Immigration Bond Information for the Mesa Verde ICE Processing Facility

Delivery bonds (i.e., immigration bonds) cannot be posted in-person directly at the Mesa Verde ICE Processing Facility. Instead, family members or associates can post an immigration bond at any of the 82 ICE-ERO facilities around the country that accept immigration bonds. The closest facility to the Mesa Verde ICE Processing Facility that accepts immigration bonds is located at 800 Truxtun Avenue, Bakersfield, CA 93301. Immigration bonds can be posted Monday-Friday (except holidays) at this facility from 9:00 AM to 3:00 PM. Bonds cannot be posted directly at the Mesa Verde ICE Processing Facility.

To post an immigration bond for someone detained at this facility, you must have a money order, cashier's check or certified check. If the bond amount exceeds \$10,000 and over, you can only pay by single cashier's check or a certified check. All payments should be made to the "US Department of Homeland Security" or "Immigration and Customs Enforcement."

If you do not want to post the bond in-person yourself, you can also have a licensed immigration bond agent post the bond for you. For a small fee, ranging from 2% – 10%, an agent can post the bond for you electronically, so that you do not have to travel to the ICE ERO facility. This process is typically faster and easier than posting a bond yourself.

Frequently asked questions about the Mesa Verde ICE Processing Facility

Does the facility have public parking?

Yes. There is free public parking available to all visitors located west of the facility on Golden State Avenue. Look for the marked visitor parking.

Can I post a bond for someone who is detained at this facility?

No. This facility does not allow families to post an immigration bond at that facility. If the family would like to post an immigration bond, they must post one in person at one of the 82 ICE-ERO offices around the country. The closest ICE-ERO office is located at 800 Truxtun Avenue, Bakersfield CA 93301. The phone number for that office is 661.328.4500.

What hours can I post an immigration bond for someone detained?

Immigration Bonds for detained family members can only be posted Monday – Friday between 9:00 AM – 3:00 PM at one of the approved ICE-ERO office locations that accepts bonds. If you decide however to use the services of a bonding agent, you are able to post an immigration bond 24/7 through a special online bonding system.

California ICE Detention Facilities

Not every ICE detention facility allows you to post an immigration bond in California. If you would like to post an immigration bond it must be done at an ICE-ERO facility that accepts immigration bonds.

There are 7 ICE detention facilities in California. They are as follows:

- Adelanto ICE Processing Center
- Santa Ana City Jail
- Yuba County Jail
- Mesa Verde ICE Processing Facility
- James A. Musick Facility
- Imperial Regional Detention Facility
- Otay Mesa Detention Center

If you need an easier way to post an immigration bond for someone who is detained at an immigration detention facility in California, **you can post an immigration bond through a licensed immigration bonding agent by calling (844) 910-2342.** That agent can post a bond for you electronically for any detention facility in California and around the US.
