

Visitation Hours: Visiting hours for the El Paso County Correctional Center are everyday from 8:00 AM-1:45 PM and 4:00 PM-9:00 PM. Additionally, there is a Video Visitation center that is open all year, including weekends and holidays. All visitors are required to call ahead and schedule visits 2 days in advance. To schedule a visit call (719) 390-2373. When you call have the following information ready:

- Who you are visiting
- What time you would like to visit (if available)
- All visitors' names only three visitors per visit (this includes children)
- Driver's license information

Attorneys can visit at any time.

Immigration Bond Information for the El Paso County Criminal Justice Center

Delivery bonds (i.e., immigration bonds) cannot be posted in-person directly at the El Paso County Correctional Center Instead, family members or associates can post an immigration bond at any of the 82 ICE-ERO facilities around the country that accept immigration bonds.

The closest facility to the El Paso County Correctional Center that accepts immigration bonds is located at Denver Contract and Detention Facility (GEO) located at 3130 N. Oakland Street, Aurora, CO 80010. Immigration bonds can be posted Monday-Friday (except holidays) at this facility from 9:00 AM to 3:00 PM. Bonds cannot be posted directly at the El Paso County Correctional Center. To post an immigration bond for someone detained at the El Paso County Correctional Center you must have a money order, cashier's check or certified check. If the bond amount exceeds \$10,000 and over, you can only pay by single cashier's check or a certified check. All payments should be made to the "US Department of Homeland Security" or "Immigration and Customs Enforcement."

If you do not want to post the bond in-person yourself, you can also have a licensed immigration bond agent post the bond for you. For a small fee, ranging from 2% - 10%, an agent can post the bond for you electronically, so that you do not have to travel to the ICE-ERO facility. This process is typically faster and easier than posting a bond yourself.

ICE Detainee Information

How to get information on an ICE detainee

Please call the Field Office Main Telephone Number, (720) 873-2899. Please have the following detainee information available:

- First name
- Last name (including hyphenated last names)
- Any aliases the detainee might use
- Date of birth
- Country of birth

How to get in touch with an ICE detainee

Please have the following detainee information available:

- Full name
- Alien Registration Number (A Number)
- Your name and telephone number



Frequently asked questions about the El Paso County Criminal Justice Center

Does the facility have public parking?

Yes there is visitor parking at the facility as well as available street parking.

Is the El Paso County Correctional Center accessible for individuals with disabilities?

Yes, according with all state and federal laws, the El Paso County Correctional Center does not discriminate based on any disability.

If I am bonding someone out of this facility, do I post the bond there or another location?

While you can bail someone out of the El Paso County Correctional Center, you cannot post the bond at that facility. The immigration bond must be posted at one of 82 ICE-ERO facilities that accept immigration bonds. The closest ICE-ERO facility near the El Paso County Correctional Center is the Denver Contract and Detention Facility (GEO) located at 3130 N. Oakland Street, Aurora, CO 80010 (303) 361-0723.

Colorado ICE Detention Facilities

Not every ICE detention facility allows you to post an immigration bond. If you would like to post an immigration bond it must be done at an ICE-ERO facility that accepts immigration bonds.

There are 3 ICE detention facilities in Colorado. They are as follows:

- Aurora Contract Detention Facility
- Teller County Detention Center
- El Paso County Criminal Justice Center

If you need an easier way to post an immigration bond for someone who is detained at an immigration detention facility, you can post an immigration bond through a licensed immigration bonding agent by calling (844) 910-2342. That agent can post a bond for you electronically for any detention facility in the US.
