
Visitation hours:

The Broward Transitional Center organizes its visiting schedule based on the gender of the detainee. The breakdown of visiting hours is as follows:

Male Detainees

- Saturday 8AM-10:30 AM-1:30 PM-4PM; Sunday 8AM-10:30 AM Female Detainees
- Sunday 1:30 PM 4:00 PM

Holiday Visitation will be 8:00~AM-10:30~AM and 1:30~PM-4:00~PM for both male and female detainees. All visitors must have a valid ID to enter the facility and all minors must be accompanied by an adult. Visits are limited to one hour. If a family is traveling a significant distance additional visiting time may be requested from the Warden. Attorneys are allowed to visit their clients from 8:00~AM to 7:30~PM Monday – Friday and from 9:00~AM-5:00~PM on the weekends and Holidays.

Immigration Bond Information for the Broward Transitional Center?

Delivery bonds (i.e., immigration bonds) cannot be posted in-person directly at the Broward Transitional Center. Instead, family members or associates can post an immigration bond at any of the 82 ICE-ERO facilities around the country that accept immigration bonds. The closest facility to the Broward Transitional Center that accepts immigration bonds is located at 18201 SW 12 Street, Miami, FL 33194. Immigration bonds can be posted Monday-Friday (except holidays) at this facility from 9:00 AM to 3:00 PM. Bonds cannot be posted directly at the Broward Transitional Center.

To post an immigration bond for someone detained at this facility you must have a money order, cashier's check or certified check. If the bond amount exceeds \$10,000 and over, you can only pay by single cashier's check or a certified check. All payments should be made to the "US Department of Homeland Security" or "Immigration and Customs Enforcement."

If you do not want to post the bond in-person yourself, you can also have a licensed immigration bond agent post the bond for you. For a small fee, ranging from 2% - 10%, an agent can post the bond for you electronically, so that you do not have to travel to the ICE ERO facility. This process is typically faster and easier than posting a bond yourself.

Frequently asked questions about the Broward Transitional Center

Does the facility have public parking?

Yes. If you know someone who is detained at the Broward Transitional Center in Pompano Beach, Florida and you would like to visit them, there is public parking available the facility. All visitor parking is marked.

Can I post a bond for someone who is detained at this facility?

If a bond has been set then yes, you may bond someone out who is being detained at the Broward Transitional Center. See the next question below, regarding the various locations where bonds can be processed.

If I am bonding someone out of this facility, do I post the bond there or another location?

While you can bail someone out of the Broward Transitional Center, you cannot post the bond at that facility. The immigration bond must be posted at one of 82 ICE-ERO facilities that accept immigration bonds. The closest ICE-ERO facility near the Broward Transitional Center is located at 18201 SW 12 Street, Miami, FL 33194. You can call this ICE-ERO location at (305) 207-2001.

Florida ICE Detention Facilities

Not every ICE detention facility allows you to post an immigration bond in Florida. If you would like to post an immigration bond it must be done at an ICE-ERO facility that accepts immigration bonds.

There are 5 ICE detention facilities in Florida. They are as follows:

- Baker County Facility
- Broward Transitional Center
- Glades County Detention Center
- Krome Service Processing Center
- Wakulla County Facility

If you need an easier way to post an immigration bond for someone who is detained at an immigration detention facility, **you** can post an immigration bond through a licensed immigration bonding agent by calling (844) 910-2342. That agent can post a bond for you electronically for any detention facility in the US.
