- Restricted Housing visitation hours are: Saturdays from 2:30 PM to 4:30 PM & Sundays from 2:30 PM to 4:30 PM

Holiday Schedule:

- Medium High to High visitation hours are: 11:15 AM to 2:15 PM
- Low to Medium Low visitation hours are: 8:00 AM to 11:00 AM
- Restricted Housing visitation hours are: 2:30 PM to 4:30 PM

Visitors should plan on arriving at least 15 minutes before their scheduled visit to allow for processing. All visitors must show a valid ID and all visits shall not exceed 60 minutes. Attorneys and paralegals are allowed to visit their clients daily from 6:00 AM – 11:00 PM.

Immigration Bond Information for the Folkston Immigration Processing Center (DR James)

Delivery bonds (i.e., immigration bonds) cannot be posted in-person directly at the Folkston Immigration Processing Center (DR James). Instead, family members or associates can post an immigration bond at any of the 82 ICE-ERO facilities around the country that accept immigration bonds. The closest facility to Folkston Immigration Processing Center (DR James) that accepts immigration bonds is located 180 Ted Turner Drive SW, 3rd Floor, Rm 337 Atlanta, GA 30303. Immigration bonds can be posted Monday-Friday (except holidays) at this facility from 9:00 AM to 3:00 PM. Bonds cannot be posted directly at the Folkston Immigration Processing Center (DR James).

To post an immigration bond for someone detained at this facility you must have a money order, cashier's check or certified check. If the bond amount exceeds \$10,000 and over, you can only pay by single cashier's check or a certified check. All payments should be made to the "US Department of Homeland Security" or "Immigration and Customs Enforcement."

If you do not want to post the bond in-person yourself, you can also have a licensed immigration bond agent post the bond for you. For a small fee, ranging from 2% - 10%, an agent can post the bond for you electronically, so that you do not have to travel to the ICE ERO facility. This process is typically faster and easier than posting a bond yourself.

Frequently asked questions about the Folkston Immigration Processing Center (DR James)

Does the facility have public parking?

Yes. If you know someone who is detained at the Folkston Immigration Processing Center (DR James) in Folkston, Georgia and you would like to visit them, there is public parking available.

Can I post a bond for someone who is detained at this facility?

If an immigration judge has set a bond in the immigrant's case, then yes, you may bond someone out of this facility. See the next question below, regarding the various locations where bonds can physically be posted and processed.

If I am bonding someone out of this facility, do I post the bond there or another location?

While you can bail someone out of the Folkston Immigration Processing Center (DR James), you cannot post the bond at that physical facility. The immigration bond must be posted at one of 82 ICE-ERO facilities that accept immigration bonds. The closes ICE-ERO facility near the Folkston Immigration Processing Center (DR James) is located at 180 Ted Turner Drive SW, 3rd Floor, Rm 337 Atlanta, GA 30303. The phone number for that facility is (404) 893-1224.

Georgia ICE Detention Facilities

There are six immigration detention facilities in Georgia.

- Irwin County Detention Center
- Stewart Detention Center
- Robert A. Deyton Detention Facility
- Folkston ICE Processing Center
- Folkston Immigration Processing Center (Annex)
- Folkston Immigration Processing Center (DR James)

None of the six detention facilities in Georgia allows you to post a Georgia immigration bond at that facility. If you would like to post an immigration bond it must be done at an ICE-ERO facility that accepts immigration bonds. In Georgia there are is one ICE-ERO facilities where you can post an immigration bond in person. The facility is located at:
