Visitation hours:

The Irwin County Detention Facility organizes its visitation hours based on the gender of the detainee. The hours of visitation are as follow:

- Male Detainees: Thursday & Saturday 1:00 PM 5:00 PM
- Female Detainees: Fridays & Sunday, 1:00 PM 5:00 PM

All visits are based on availability and are limited to one hour. The facility recommends you arrive at least 45 minutes ahead of your scheduled time so you can be processed appropriate through security. All visitors must show a valid ID.

Attorneys and paralegals are allowed to visit their clients seven days a week at any time (including holidays).

The Irwin County Detention Facility is piloting video conferencing via Skype. Please contact the facility to learn more.

Immigration Bond Information for the Irwin County Detention Center

Delivery bonds (i.e., immigration bonds) cannot be posted in-person directly at the Irwin County Detention Center. Instead, family members or associates can post an immigration bond at any of the 82 ICE-ERO facilities around the country that accept immigration bonds. The closest facility to the Irwin County Detention Center that accepts immigration bonds is located 180 Ted Turner Drive SW, 3rd Floor, Rm 337 Atlanta, GA 30303. Immigration bonds can be posted Monday-Friday (except holidays) at this facility from 9:00 AM to 3:00 PM.

To post an immigration bond for someone detained at this facility you must have a money order, cashier's check or certified check. If the bond amount exceeds \$10,000 and over, you can only pay by single cashier's check or a certified check. All payments should be made to the "US Department of Homeland Security" or "Immigration and Customs Enforcement."

If you do not want to post the bond in-person yourself, you can also have a licensed immigration bond agent post the bond for you. For a small fee, ranging from 2% - 10%, an agent can post the bond for you electronically, so that you do not have to travel to the ICE ERO facility. This process is typically faster and easier than posting a bond yourself.

Frequently asked questions about the Irwin County Detention Center

Does the facility have public parking?

Yes. If you know someone who is detained at the Irwin County Detention Center in Ocilla, Georgia and you would like to visit them, there is free public parking available. The parking will be designated for visitors.

Can I post a bond for someone who is detained at this facility?

If an immigration judge has set a bond in the immigrant's case, then yes, you may bond someone out of this facility. See the next question below, regarding the various locations where bonds can physically be posted and processed.

If I am bonding someone out of this facility, do I post the bond there or another location?

While you can bail someone out of the Irwin County Detention Center, you cannot post the bond at that physical facility. The immigration bond must be posted at one of 82 ICE-ERO facilities that accept immigration bonds. The closes ICE-ERO facility near the Irwin County Detention Center is located at 180 Ted Turner Drive SW, 3rd Floor, Rm 337 Atlanta, GA 30303. The phone number for that facility is (404) 893-1224.

What is the easiest way to bond an alien/immigrant out of this center?

There are two ways to bond an alien/immigrant out of the Irwin County Detention Center. First, one can show up at one of the 82 ICE-ERO bond accepting offices in person during business hours. Second, someone can utilize the services of a bonding agent who is able to post the bond electronically so that family members do not have to go to one of these ICE-ERO locations in person. Additionally, when a family uses the services of a bonding agent the detained individual will be released much sooner.

Georgia ICE Detention Facilities

There are six immigration detention facilities in Georgia.

- Irwin County Detention Center
- Stewart Detention Center
- Robert A. Deyton Detention Facility
- Folkston ICE Processing Center
- Folkston Immigration Processing Center (Annex)
- Folkston Immigration Processing Center (DR James)

None of the six detention facilities in Georgia allows you to post a Georgia immigration bond at that facility. If you would like to post an immigration bond it must be done at an ICE-ERO facility that accepts immigration bonds. In Georgia there are is one ICE-ERO facilities where you can post an immigration bond in person. The facility is located at:
