

The Jefferson County Justice Center visitation are Sunday through Saturday during the following hours:

- 8:00 AM 11:30 AM
- 1:00 PM 5:00 PM
- 6:30 PM 9:00 PM

All visits are based on availability and are limited to one 1 hour visit a week which can also be broken into two 30 minute visits. The facility recommends you arrive at least 45 minutes ahead of your scheduled time so you can be processed appropriate through security. All visitors must show a valid ID.

Attorneys and paralegals are allowed to visit their clients seven days a week from 8:00 AM - 5:00 PM.

Immigration Bond Information for the Jefferson County Justice Center

Delivery bonds (i.e., immigration bonds) cannot be posted in-person directly at Jefferson County Justice Center. Instead, family members or associates can post an immigration bond at any of the 82 ICE-ERO facilities around the country that accept immigration bonds. The closest facility to the Jefferson County Justice Center that accepts immigration bonds is located 180 Ted Turner Drive SW, 3rd Floor, Rm 337 Atlanta, GA 30303. Immigration bonds can be posted Monday-Friday (except holidays) at this facility from 9:00 AM to 3:00 PM. Bonds cannot be posted directly at the Jefferson County Justice Center.

To post an immigration bond for someone detained at this facility you must have a money order, cashier's check or certified check. If the bond amount exceeds \$10,000 and over, you can only pay by single cashier's check or a certified check. All payments should be made to the "US Department of Homeland Security" or "Immigration and Customs Enforcement."

If you do not want to post the bond in-person yourself, you can also have a licensed immigration bond agent post the bond for you. For a small fee, ranging from 2% - 10%, an agent can post the bond for you electronically, so that you do not have to travel to the ICE ERO facility. This process is typically faster and easier than posting a bond yourself.

Frequently asked questions about the Jefferson County Justice Center

Does the facility have public parking?

Yes. If you know someone who is detained at Jefferson County Justice Center in Mount Vernon, Illinois and you would like to visit them, there is public parking available. The parking is located on 9th Street and Casey Street.

Can I post a bond for someone who is detained at this facility?

If an immigration judge has set a bond in the immigrant's case, then yes, you may bond someone out of this facility. See the next question below, regarding the various locations where bonds can physically be posted and processed.

If I am bonding someone out of this facility, do I post the bond there or another location?

While you can bail someone out of the Jefferson County Justice Center, you cannot post the bond at that physical facility. The immigration bond must be posted at one of 82 ICE-ERO facilities that accept immigration bonds. The closest ICE-ERO facility is located at 101 W. Congress Parkway, Suite 4000, Chicago, IL 60605. The phone number for that facility is (312) 347-2400.

Illinois ICE Detention Facilities

There are three immigration detention facilities in Illinois.

- Jefferson County Justice Center
- McHenry County Adult Correctional Facility
- Pulaski County Detention Center

None of the three detention facilities in Illinois allows you to post an immigration bond at that facility. If you would like to post an immigration bond it must be done at an ICE-ERO facility that accepts immigration bonds. In Illinois there is one ICE-ERO facility where you can post an immigration bond in person. The facility is located at:

If you need an easier way to post an immigration bond for someone who is detained at an immigration detention facility, you can post an immigration bond through a licensed immigration bonding agent by calling (844) 910-2342. That agent can post a bond for you electronically for any detention facility in the US.
