Immigration Bond Information for the McHenry County Adult Correctional Facility

Delivery bonds (i.e., immigration bonds) cannot be posted in-person directly at this facility. Instead, family members or associates can post an immigration bond at any of the 82 ICE-ERO facilities around the country that accept immigration bonds. The closest facility to McHenry County Adult Correctional Facility that accepts immigration bonds is located 101 W. Congress Parkway, Suite 4000, Chicago, IL 60605. Immigration bonds can be posted Monday-Friday (except holidays) at this facility from 9:00 AM to 3:00 PM. Bonds cannot be posted directly at the McHenry County Adult Correctional Facility.

To post an immigration bond for someone detained at this facility you must have a money order, cashier's check or certified check. If the bond amount exceeds \$10,000 and over, you can only pay by single cashier's check or a certified check. All payments should be made to the "US Department of Homeland Security" or "Immigration and Customs Enforcement."

If you do not want to post the bond in-person yourself, you can also have a licensed immigration bond agent post the bond for you. For a small fee, ranging from 2% - 10%, an agent can post the bond for you electronically, so that you do not have to travel to the ICE ERO facility. This process is typically faster and easier than posting a bond yourself.

Frequently asked questions about the McHenry County Adult Correctional Facility

Does the facility have public parking?

Yes. If you know someone who is detained at the McHenry County Adult Correctional Facility in Woodstock, Illinois and you would like to visit them, there is public parking available.

Can I post a bond for someone who is detained at this facility?

If an immigration judge has set a bond in the immigrant's case, then yes, you may bond someone out of this facility. See the next question below, regarding the various locations where bonds can physically be posted and processed.

If I am bonding someone out of this facility, do I post the bond there or another location?

While you can bail someone out of the McHenry County Adult Correctional Facility, you cannot post the bond at that physical facility. The immigration bond must be posted at one of 82 ICE-ERO facilities that accept immigration bonds. The closes ICE-ERO facility near the McHenry County Adult Correctional Facility is located at 101 W. Congress Parkway, Suite 4000, Chicago, IL 60605. The phone number for that facility is (312) 347-2400.

Illinois ICE Detention Facilities

There are three immigration detention facilities in Illinois.

- Jefferson County Justice Center
- McHenry County Adult Correctional Facility
- Pulaski County Detention Center

None of the three detention facilities in Illinois allows you to post an immigration bond at that facility. If you would like to post an immigration bond it must be done at an ICE-ERO facility that accepts immigration bonds. In Illinois there is one ICE-ERO facility where you can post an immigration bond in person. The facility is located at:

If you need an easier way to post an immigration bond for someone who is detained at an immigration detention facility, **you can post an immigration bond through a licensed immigration bonding agent by calling (844) 910-2342**.
