

Visitation hours at the Clay County Jail are broken out as follows:

- Monday Thursday 8:00 AM 8:00 PM
- Saturday 8:00 AM 12:00 PM

The facility recommends you arrive at least 45 minutes ahead of your scheduled time so you can be processed appropriate through security. All visitors must be prepared to show a valid ID and visits are not to exceed 60 minutes.

Attorneys can visit clients daily from 8:30 AM – 5:00 PM.

Immigration Bond Information for the Clay County Jail

Delivery bonds (i.e., immigration bonds) cannot be posted in-person directly at the Clay County Jail. Instead, family members or associates can post an immigration bond at any of the 82 ICE-ERO facilities around the country that accept immigration bonds. The closest facility to the Clay County Jail that accepts immigration bonds is located at 7355 Woodland Drive, Indianapolis, IN 46278. Immigration bonds can be posted Monday-Friday (except holidays) at this facility from 9:00 AM to 3:00 PM. Bonds cannot be posted directly at the Clay County Jail.

To post an immigration bond for someone detained at this facility you must have a money order, cashier's check or certified check. If the bond amount exceeds \$10,000 and over, you can only pay by single cashier's check or a certified check. All payments should be made to the "US Department of Homeland Security" or "Immigration and Customs Enforcement."

If you do not want to post the bond in-person yourself, you can also have a licensed immigration bond agent post the bond for you. For a small fee, ranging from 2% - 10%, an agent can post the bond for you electronically, so that you do not have to travel to the ICE ERO facility. This process is typically faster and easier than posting a bond yourself.

Frequently asked questions about the Clay County Jail

Does the facility have public parking?

Yes. If you know someone who is detained at the Clay County Jail in Brazil, Indiana and you would like to visit them, there is parking available on the east side of the building.

Can I post a bond for someone who is detained at this facility?

If an immigration judge has set a bond in the immigrant's case, then yes, you may bond someone out of this facility. See the next question below, regarding the various locations where bonds can physically be posted and processed.

If I am bonding someone out of this facility, do I post the bond there or another location?

While you can bail someone out of the Clay County Jail, you cannot post the bond at that facility. The immigration bond must be posted at one of 82 ICE-ERO facilities that accept immigration bonds. The closes ICE-ERO facility near the Clay County Jail is located at 7355 Woodland Drive, Indianapolis, IN 46278. The phone number for that facility is (317) 216-0260.

Indiana ICE Detention Facilities

There is one immigration detention facility in Indiana.

· Clay County Jail

The Clay County detention facility in Indiana does not allow you to post an immigration bond at that facility. If you would like to post an immigration bond in Indiana it must be done at an ICE-ERO facility that accepts immigration bonds. In Indiana there is one ICE-ERO facility where you can post an immigration bond in person. The one location where you can post an immigration bond in Indiana is:

If you need an easier way to post an immigration bond for someone who is detained at an immigration detention facility, you can post an immigration bond through a licensed immigration bonding agent by calling (844) 910-2342. That agent can post a bond for you electronically for any detention facility in the US.
