
The visitation hours for the Carver County Jail Services are below:

Visitors must all be pre-approved through the facility's program office at least two days prior to the designated visitation day. Each detainee gets a list of five visitors.

You should always plan on arriving at least 45 minutes before the scheduled visitation time so you can be processed appropriately through security. All visitors must show a valid ID.

Attorneys can visit their clients at any time but are asked to avoid mealtimes.

Immigration Bond Information for the Carver County Jail Services

Delivery bonds (i.e., immigration bonds) cannot be posted in-person directly at the Carver County Jail Services. Instead, family members or associates can post an immigration bond at any of the 82 ICE-ERO facilities around the country that accept immigration bonds. The closest facility to the Carver County Jail Services that accepts immigration bonds is located at 1 Federal Drive Suite 1640, Fort Snelling, MN 55111. The number there is (612) 843-8600. Immigration bonds can be posted Monday-Friday (except holidays) at this facility from 9:00 AM to 3:00 PM. Bonds cannot be posted directly at the Carver County Jail Services.

To post an immigration bond for someone detained at this facility you must have a money order, cashier's check or certified check. If the bond amount exceeds \$10,000 and over, you can only pay by single cashier's check or a certified check. All payments should be made to the "US Department of Homeland Security" or "Immigration and Customs Enforcement."

If you do not want to post the bond in-person yourself, you can also have a licensed immigration bond agent post the bond for you. For a small fee, ranging from 2% - 10%, an agent can post the bond for you electronically, so that you do not have to travel to the ICE ERO facility. This process is typically faster and easier than posting a bond yourself.

Frequently asked questions about the Carver County Jail Services

Does the facility have public parking?

Yes. If you know someone who is detained at the Carver County Jail Services in Elk River, Minnesota and you would like to visit them, there is public parking adjacent to the facility.

Can I post a bond for someone who is detained at this facility?

If an immigration judge has set a bond in the immigrant's case, then yes, you may bond someone out of this facility. See the next question below, regarding the various locations where bonds can physically be posted and processed.

If I am bonding someone out of this facility, do I post the bond there or another location?

While you can bail someone out of the Carver County Jail Services, you cannot post the bond at that facility. The immigration bond must be posted at one of 82 ICE-ERO facilities that accept immigration bonds. The closest ICE-ERO facility near the Carver County Jail Services is located at 1 Federal Drive Suite 1640, Fort Snelling, MN 55111. The number there is (612) 843-8600.

Minnesota ICE Detention Facilities

There are four ICE Immigration detention facilities in Minnesota. This includes:

- Freeborn County Jail Services
- Sherburne County Jail Services
- Carver County Jail Services
- Northwest Regional Corrections Center/Polk County Jail

Not every detention facility allows you to post an immigration bond in Minnesota. If you would like to post an immigration bond it must be done at an ICE-ERO facility that accepts immigration bonds. In Minnesota there is one ICE-ERO Facility where you can post an immigration bond in person. This facility is located at the following address:
