The facility recommends you arrive at least 45 minutes ahead of your scheduled time so you can be processed appropriate through security. All visitors must be prepared to show a valid ID and visits are not to exceed 30 minutes.

Attorneys can visit clients daily from 9:00 AM – 3:00 PM, including holidays.

# **Immigration Bond Information for the Montgomery County Jail**

Delivery bonds (i.e., immigration bonds) cannot be posted in-person directly at the Montgomery County Jail. Instead, family members or associates can post an immigration bond at any of the 82 ICE-ERO facilities around the country that accept immigration bonds. The closest facility to the Montgomery County Jail that accepts immigration bonds is located at 1222 Spruce Street, Room 1.100, St. Louis, MO 63103. The phone number there is (314) 244-9787. Immigration bonds can be posted Monday-Friday (except holidays) at this facility from 9:00 AM to 3:00 PM. Bonds cannot be posted directly at the Montgomery County Jail.

To post an immigration bond for someone detained at this facility you must have a money order, cashier's check or certified check. If the bond amount exceeds \$10,000 and over, you can only pay by single cashier's check or a certified check. All payments should be made to the "US Department of Homeland Security" or "Immigration and Customs Enforcement."

If you do not want to post the bond in-person yourself, you can also have a licensed immigration bond agent post the bond for you. For a small fee, ranging from 2% - 10%, an agent can post the bond for you electronically, so that you do not have to travel to the ICE ERO facility. This process is typically faster and easier than posting a bond yourself.

# Frequently asked questions about the Montgomery County Jail

### Does the facility have public parking?

Yes. If you know someone who is detained at the Montgomery County Jail in Montgomery City, Missouri and you would like to visit them, there is parking available on the east side of the building.

### Can I post a bond for someone who is detained at this facility?

If an immigration judge has set a bond in the immigrant's case, then yes, you may bond someone out of this facility. See the next question below, regarding the various locations where bonds can physically be posted and processed.

#### If I am bonding someone out of this facility, do I post the bond there or another location?

While you can bail someone out of the Montgomery County Jail, you cannot post the bond at that facility. The immigration bond must be posted at one of 82 ICE-ERO facilities that accept immigration bonds. The closes ICE-ERO facility near the Montgomery County Jail is located at 1222 Spruce Street, Room 1.100, St. Louis, MO 63103. The phone number there is (314) 244-9787.

## Missouri ICE Detention Facilities

There is one ICE immigration detention facility in Missouri.

Montgomery County Jail

The Montgomery County Jail in Missouri does not allow you to post an immigration bond at that facility. If you would like to post an immigration bond in Missouri it must be done at an ICE-ERO facility that accepts immigration bonds. In Missouri there are three ICE-ERO facilities where you can post an immigration bond in person. The three locations where you can post an immigration bond in Missouri are:
