

All visits are on a first come first serve basis. You should always plan on arriving at least 15 minutes before the scheduled visitation time so you can be processed appropriately through security. All visitors must show a valid ID and visits will last 60 minutes.

Attorneys are allowed to visit their clients at any time but advised to avoid mealtimes.

Immigration Bond Information for the Cass County Jail Services

Delivery bonds (i.e., immigration bonds) cannot be posted in-person directly at the Cass County Jail Services. Instead, family members or associates can post an immigration bond at any of the 82 ICE-ERO facilities around the country that accept immigration bonds. The closest facility to the Cass County Jail Services that accepts immigration bonds is located at 1717 Avenue H, Omaha, NE 68110. The number there is (402) 536-4861. Immigration bonds can be posted Monday-Friday (except holidays) at this facility from 9:00 AM to 3:00 PM. Bonds cannot be posted directly at the Cass County Jail Services.

To post an immigration bond for someone detained at this facility you must have a money order, cashier's check or certified check. If the bond amount exceeds \$10,000 and over, you can only pay by single cashier's check or a certified check. All payments should be made to the "US Department of Homeland Security" or "Immigration and Customs Enforcement."

If you do not want to post the bond in-person yourself, you can also have a licensed immigration bond agent post the bond for you. For a small fee, ranging from 2% - 10%, an agent can post the bond for you electronically, so that you do not have to travel to the ICE ERO facility. This process is typically faster and easier than posting a bond yourself.

Frequently asked questions about the Cass County Jail Services

Does the facility have public parking?

Yes. If you know someone who is detained at the Cass County Jail Services in Plattsmouth, Nebraska and you would like to visit them, there is free public parking available at the facility.

Can I post a bond for someone who is detained at this facility?

If an immigration judge has set a bond in the immigrant's case, then yes, you may bond someone out of this facility. See the next question below, regarding the various locations where bonds can physically be posted and processed.

If I am bonding someone out of this facility, do I post the bond there or another location?

While you can bail someone out of the Cass County Jail Services, you cannot post the bond at that facility. The immigration bond must be posted at one of 82 ICE-ERO facilities that accept immigration bonds. The closest ICE-ERO facility near the Cass County Jail Services is located at 1717 Avenue H, Omaha, NE 68110. The number there is (402) 536-4861.

Nebraska ICE Detention Facilities

There are three ICE Immigration detention facilities in Nebraska. This includes:

- Douglas County Department of Corrections
- Hall County Department of Corrections
- Cass County Jail Services

Not every detention facility allows you to post an immigration bond in Nebraska. If you would like to post an immigration bond it must be done at an ICE-ERO facility that accepts immigration bonds. In Nebraska there is one ICE-ERO Facility where you can post an immigration bond in person. This facility is located at the following address:

If you need an easier way to post an immigration bond for someone who is detained at an immigration detention facility, you can post an immigration bond through a licensed immigration bonding agent by calling (844) 910-2342. That agent can post a bond for you electronically for any detention facility in the US.
