The visitation hours for the Hall County Department of Corrections are organized into onsite and internet-based visits. They are broken out as follows:

- 8:00 AM to 12:00 PM •

All onsite visits must be scheduled 24 hours ahead of time and internet-based visitations must be scheduled 30 minutes ahead of time. All internet visitors must submit an appropriate photo and identification to the lobby officer.

You should always plan on arriving at least 45 minutes before the scheduled visitation time so you can be processed appropriately through security. All visitors must show a valid ID.

Immigration Bond Information for the Hall County Department of Corrections?

Delivery bonds (i.e., immigration bonds) cannot be posted in-person directly at the Hall County Department of Corrections. Instead, family members or associates can post an immigration bond at any of the 82 ICE-ERO facilities around the country that accept immigration bonds. The closest facility to the Hall County Department of Corrections that accepts immigration bonds is located at 1717 Avenue H, Omaha, NE 68110. The number there is (402) 536-4861. Immigration bonds can be posted Monday-Friday (except holidays) at this facility from 9:00 AM to 3:00 PM. Bonds cannot be posted directly at the Hall County Department of Corrections.

To post an immigration bond for someone detained at this facility you must have a money order, cashier's check or certified check. If the bond amount exceeds \$10,000 and over, you can only pay by single cashier's check or a certified check. All payments should be made to the "US Department of Homeland Security" or "Immigration and Customs Enforcement."

If you do not want to post the bond in-person yourself, you can also have a licensed immigration bond agent post the bond for you. For a small fee, ranging from 2% - 10%, an agent can post the bond for you electronically, so that you do not have to travel to the ICE ERO facility. This process is typically faster and easier than posting a bond yourself.

Frequently asked questions about the Hall County Department of Corrections

Does the facility have public parking?

Yes. If you know someone who is detained at the Hall County Department of Corrections in Grand Island, Nebraska and you would like to visit them, there is free public parking available at the facility.

Can I post a bond for someone who is detained at this facility?

If an immigration judge has set a bond in the immigrant's case, then yes, you may bond someone out of this facility. See the next question below, regarding the various locations where bonds can physically be posted and processed.

If I am bonding someone out of this facility, do I post the bond there or another location?

While you can bail someone out of the Hall County Department of Corrections, you cannot post the bond at that facility. The immigration bond must be posted at one of 82 ICE-ERO facilities that accept immigration bonds. The closest ICE-ERO facility near the Hall County Department of Corrections is located at 1717 Avenue H, Omaha, NE 68110. The number there is (402) 536-4861.

Nebraska ICE Detention Facilities

There are three ICE Immigration detention facilities in Nebraska. This includes:

- Douglas County Department of Corrections
- Hall County Department of Corrections
- Cass County Jail Services

Not every detention facility allows you to post an immigration bond in Nebraska. If you would like to post an immigration bond it must be done at an ICE-ERO facility that accepts immigration bonds. In Nebraska there is one ICE-ERO Facility where you can post an immigration bond in person. This facility is located at the following address:
