

Children under the age of 18 must be with a parent or legal guardian at all times You must stay seated at all times. You may hold hands over the barrier. NO kissing allowed. You may give a brief hug at the beginning and end of each visit. No items will be passed between the visitor and the detainee. Attorneys can visit clients seven days a week at anytime.

### **Immigration Bond Information for the Allegany County Jail**

Delivery bonds (i.e., immigration bonds) cannot be posted in-person directly at the Allegany County Jail. Instead, family members or associates can post an immigration bond at any of the 82 ICE-ERO facilities around the country that accept immigration bonds. The closest facility to the Allegany County Jail that accepts immigration bonds is located at 1086 Troy-Schenectady Road, Latham, NY 12110. The number there is (518) 220-2185. Immigration bonds can be posted Monday-Friday (except holidays) at this facility from 9:00 AM to 3:00 PM. Bonds cannot be posted directly at the Allegany County Jail.

To post an immigration bond for someone detained at this facility you must have a money order, cashier's check or certified check. If the bond amount exceeds \$10,000 and over, you can only pay by single cashier's check or a certified check. All payments should be made to the "US Department of Homeland Security" or "Immigration and Customs Enforcement."

If you do not want to post the bond in-person yourself, you can also have a licensed immigration bond agent post the bond for you. For a small fee, ranging from 2% - 10%, an agent can post the bond for you electronically, so that you do not have to travel to the ICE ERO facility. This process is typically faster and easier than posting a bond yourself.

- Last name (including hyphenated last names)
- Any aliases the detainee might use
- Date of birth
- Country of birth

Please have the following detainee information available:

- Full name
- Alien Registration Number (A Number)
- Your name and telephone number

# Frequently asked questions about the Allegany County Jail

#### Does the facility have public parking?

Yes. If you know someone who is detained at Allegany County Jail in Belmont, New York and you would like to visit them, there is free parking in front the facility. Visitor parking is marked.

#### Can I post a bond for someone who is detained at this facility?

If an immigration judge has set a bond in the immigrant's case, then yes, you may bond someone out of this facility. See the next question below, regarding the various locations where bonds can physically be posted and processed.

#### If I am bonding someone out of this facility, do I post the bond there or another location?

While you can bail someone out of the Allegany County Jail, you cannot post the bond at that facility. The immigration bond must be posted at one of 82 ICE-ERO facilities that accept immigration bonds. The closes ICE-ERO facility near the Allegany County Jail is located at 1086 Troy-Schenectady Road, Latham, NY 12110. The number there is (518) 220-2185.

### **New York ICE Detention Facilities**

There are seven ICE immigration detention facility in New York.

- Buffalo Federal Detention Facility
- Orange County Correctional Facility
- Albany County Correctional Facility
- Allegany County Jail
- Chautauqua County Jail
- Clinton County Jail
- Wayne County Jail

Not every detention facility allows you to post an immigration bond in New York. If you would like to post an immigration bond in New York it must be done at an ICE-ERO facility that accepts immigration bonds. In New York there are two ICE-ERO facilities where you can post an immigration bond in person. These facilities are at:

If you need an easier way to post an immigration bond for someone who is detained at an immigration detention facility, **you can post an immigration bond through a licensed immigration bonding agent by calling (844) 910-2342**. That agent can post a bond for you electronically for any detention facility in the US.
