Immigration Bond Information for the Wayne County Jail

Delivery bonds (i.e., immigration bonds) cannot be posted in-person directly at the Wayne County Jail. Instead, family members or associates can post an immigration bond at any of the 82 ICE-ERO facilities around the country that accept immigration bonds. The closest facility to the Wayne County Jail that accepts immigration bonds is located at 4250 Federal Drive, Batavia, NY 14020. The number there is (585) 344-6500. Immigration bonds can be posted Monday-Friday (except holidays) at this facility from 9:00 AM to 3:00 PM. Bonds cannot be posted directly at the Wayne County Jail.

To post an immigration bond for someone detained at this facility you must have a money order, cashier's check or certified check. If the bond amount exceeds \$10,000 and over, you can only pay by single cashier's check or a certified check. All payments should be made to the "US Department of Homeland Security" or "Immigration and Customs Enforcement."

If you do not want to post the bond in-person yourself, you can also have a licensed immigration bond agent post the bond for you. For a small fee, ranging from 2% - 10%, an agent can post the bond for you electronically, so that you do not have to travel to the ICE ERO facility. This process is typically faster and easier than posting a bond yourself.

Frequently asked questions about the Wayne County Jail

Does the facility have public parking?

Yes. If you know someone who is detained at Wayne County Jail in Lyons, New York and you would like to visit them, there is free parking in front the facility. Visitor parking is marked.

Can I post a bond for someone who is detained at this facility?

If an immigration judge has set a bond in the immigrant's case, then yes, you may bond someone out of this facility. See the next question below, regarding the various locations where bonds can physically be posted and processed.

If I am bonding someone out of this facility, do I post the bond there or another location?

While you can bail someone out of the Wayne County Jail, you cannot post the bond at that facility. The immigration bond must be posted at one of 82 ICE-ERO facilities that accept immigration bonds. The closes ICE-ERO facility near the Wayne County Jail is located at 4250 Federal Drive, Batavia, NY 14020. The number there is (585) 344-6500.

Not every detention facility allows you to post an immigration bond in New York. If you would like to post an immigration bond in New York it must be done at an ICE-ERO facility that accepts immigration bonds.
