Visits are not allowed to exceed 30 minutes. Please arrive early and allow at least 15 minutes to be processed into the facility. All visitors must show a valid ID.

Attorneys are allowed to visit their clients daily. On regular business days, legal visits are allowed for up to eight hours and on weekends and holidays, visits are allowed up to four hours.

Immigration Bond Information for the Virginia Peninsula Regional Jail

Delivery bonds (i.e., immigration bonds) cannot be posted in-person directly at the Virginia Peninsula Regional Jail. Instead, family members or associates can post an immigration bond at any of the 82 ICE-ERO facilities around the country that accept immigration bonds. The closest facility to the Virginia Peninsula Regional Jail that accepts immigration bonds is located at 9200 Arboretum Parkway, Suite 140, Richmond, VA 23236. The number there is (804) 330-8250. Immigration bonds can be posted Monday-Friday (except holidays) at this facility from 9:00 AM to 3:00 PM. Bonds cannot be posted directly at the Virginia Peninsula Regional Jail.

To post an immigration bond for someone detained at this facility you must have a money order, cashier's check or certified check. If the bond amount exceeds \$10,000 and over, you can only pay by single cashier's check or a certified check. All payments should be made to the "US Department of Homeland Security" or "Immigration and Customs Enforcement."

If you do not want to post the bond in-person yourself, you can also have a licensed immigration bond agent post the bond for you. For a small fee, ranging from 2% - 10%, an agent can post the bond for you electronically, so that you do not have to travel to the ICE ERO facility. This process is typically faster and easier than posting a bond yourself.

- Country of birth

Frequently asked questions about the Virginia Peninsula Regional Jail

Does the facility have public parking?

Yes. If you know someone who is detained at the Virginia Peninsula Regional Jail in Williamsburg, Virginia and you would like to visit them, there is public parking adjacent to the facility.

Can I post a bond for someone who is detained at this facility?

If an immigration judge has set a bond in the immigrant's case, then yes, you may bond someone out of this facility. See the next question below, regarding the various locations where bonds can physically be posted and processed.

If I am bonding someone out of this facility, do I post the bond there or another location?

While you can bail someone out of the Virginia Peninsula Regional Jail, you cannot post the bond at that facility. The immigration bond must be posted at one of 82 ICE-ERO facilities that accept immigration bonds. The closest ICE-ERO facility near the Virginia Peninsula Regional Jail is located at 9200 Arboretum Parkway, Suite 140, Richmond, VA 23236. The number there is (804) 330-8250.

Virginia ICE Detention Facilities

There are three Immigration Detention Facilities in Virginia. This includes:

- Farmville Detention Center
- Virginia Peninsula Regional Jail
- Caroline Detention Facility

Not every detention facility allows you to post an immigration bond in Virginia. If you would like to post an immigration bond it must be done at an ICE-ERO facility that accepts immigration bonds. In Virginia there are two ICE-ERO Facilities where you can post an immigration bond in person. These facilities are located at the following addresses:

If you need an easier way to post an immigration bond for someone who is detained at an immigration detention facility, you can post an immigration bond through a licensed immigration bonding agent by calling (844) 910-2342. That agent can post a bond for you electronically for any detention facility in the US.
