If you would like to get information on a detainee at the Karnes County Residential Center, please call (830) 254-2000 between the hours of 8:00 AM – 8:00 PM.

Visitation hours at the Karnes County Residential Center are broken out as follows:

Monday – Sunday 8:00 AM – 8:00 PM

Visitors are allowed 60 minutes for visits. The facility recommends you arrive at least 45 minutes ahead of your scheduled time so you can be processed appropriately through security. Attorneys can visit clients seven days a week from 8:00 AM - 8:00 PM (including holidays).

### **Immigration Bond Information for the Karnes County Residential Center**

Delivery bonds (i.e., immigration bonds) can be posted in-person directly at the Karnes County Residential Center. The phone number there is (830) 254-2500. Immigration bonds can be posted Monday-Friday (except holidays) at this facility from 9:00 AM to 3:00 PM.

To post an immigration bond for someone detained at this facility you must have a money order, cashier's check or certified check. If the bond amount exceeds \$10,000 and over, you can only pay by single cashier's check or a certified check. All payments should be made to the "US Department of Homeland Security" or "Immigration and Customs Enforcement."

If you do not want to post the bond in-person yourself, you can also have a licensed immigration bond agent post the bond for you. For a small fee, ranging from 2% - 10%, an agent can post the bond for you electronically, so that you do not have to travel to the ICE ERO facility. This process is typically faster and easier than posting a bond yourself.

- Any aliases the detainee might use
- Date of birth
- Country of birth

- Alien Registration Number (A Number)
- Your name and telephone number

## Frequently asked questions about the Karnes County Residential Center

#### Does the facility have public parking?

If you know someone who is detained at Karnes County Residential Center in Karnes City, Texas and you would like to visit them, there is parking available at the facility located at Building C3.

#### Can I post a bond for someone who is detained at this facility?

If an immigration judge has set a bond in the immigrant's case, then yes, you may bond someone out of this facility. See the next question below, regarding the various locations where bonds can physically be posted and processed.

#### If I am bonding someone out of this facility, do I post the bond there or another location?

While you can bail someone out of the Karnes County Residential Center, you can also post the bond at this facility as it is one of the 82 ICE-ERO facilities that accept immigration bonds. The phone number there is (830) 254-2500.

Not every detention facility allows you to post an immigration bond in Texas. If you would like to post an immigration bond in Texas it must be done at an ICE-ERO facility that accepts immigration bonds. In Texas there are eleven ICE-ERO facilities where you can post an immigration bond in person.
