

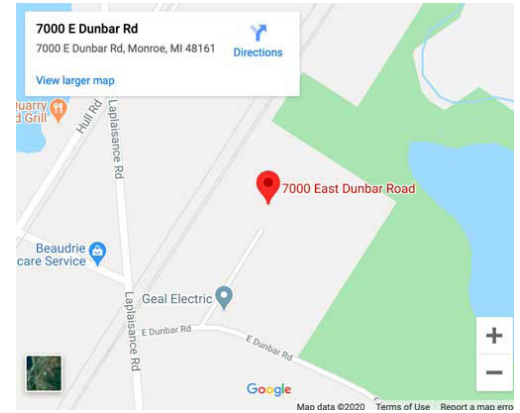

The visitation hours for the Monroe County Jail are broken out as follows:

Saturday	Sunday
9:00 AM – 11:00 AM	9:00 AM – 11:00 AM
1:00 PM – 4:00 PM	1:00 PM – 4:00 PM
6:00 PM – 9:00 PM	6:00 PM – 9:00 PM

You should always plan on arriving at least 45 minutes before the scheduled visitation time so you can be processed appropriately through security. All visitors must show a valid ID.

Attorneys are allowed to visit their clients seven days a week with no restrictions except an emergency.

## Immigration Bond Information for the Monroe County Jail

Delivery bonds (i.e., immigration bonds) cannot be posted in-person directly at the Monroe County Jail. Instead, family members or associates can post an immigration bond at any of the 82 ICE-ERO facilities around the country that accept immigration bonds. The closest facility to the Monroe County Jail that accepts immigration bonds is located at 333 Mt. Elliott, Detroit, MI 48207. The number there is (313) 394-2500. Immigration bonds can be posted Monday-Friday (except holidays) at this facility from 9:00 AM to 3:00 PM. Bonds cannot be posted directly at the Monroe County Jail.

To post an immigration bond for someone detained at this facility you must have a money order, cashier's check or certified check. If the bond amount exceeds \$10,000 and over, you can only pay by single cashier's check or a certified check. All payments should be made to the "US Department of Homeland Security" or "Immigration and Customs Enforcement."

If you do not want to post the bond in-person yourself, you can also have a licensed immigration bond agent post the bond for you. For a small fee, ranging from 2% – 10%, an agent can post the bond for you electronically, so that you do not have to travel to the ICE ERO facility. This process is typically faster and easier than posting a bond yourself.

### How to get information on an ICE detainee

Please call the Field Office Main Telephone Number, (313) 568-6049. Please have the following detainee information available:

- First name
- Last name (including hyphenated last names)
- Any aliases the detainee might use
- Date of birth
- Country of birth

### How to get in touch with an ICE detainee

Please have the following detainee information available:

- Full name
- Alien Registration Number (A Number)
- Your name and telephone number

## Frequently asked questions about the Monroe County Jail

### *Does the facility have public parking?*

Yes. If you know someone who is detained at the Monroe County Jail in Monroe, Michigan and you would like to visit them, there is public parking adjacent to the facility.

### *Can I post a bond for someone who is detained at this facility?*

If an immigration judge has set a bond in the immigrant's case, then yes, you may bond someone out of this facility. See the next question below, regarding the various locations where bonds can physically be posted and processed.

### *If I am bonding someone out of this facility, do I post the bond there or another location?*

While you can bail someone out of the Monroe County Jail, you cannot post the bond at that facility. The immigration bond must be posted at one of 82 ICE-ERO facilities that accept immigration bonds. The closest ICE-ERO facility near the correctional center is located at 333 Mt. Elliott, Detroit, MI 48207. The number there is (313) 394-2500.

## Michigan ICE Detention Facilities

There are three ICE Immigration detention facilities in Michigan. This includes:

- Calhoun County Correctional Center
- Monroe County Jail
- St. Clair County Jail

Not every detention facility allows you to post an immigration bond in Michigan. If you would like to post an immigration bond it must be done at an ICE-ERO facility that accepts immigration bonds. In Michigan there is one ICE-ERO Facility where you can post an immigration bond in person. This facility is located at the following address:

If you need an easier way to post an immigration bond for someone who is detained at an immigration detention facility, **you can post an immigration bond through a licensed immigration bonding agent by calling (844) 910-2342**. That agent can post a bond for you electronically for any detention facility in the US.
