



Visitation hours:

Monday – Friday 9:00 AM – 11:00 AM 1:00 PM- 3:00 PM 6:00 PM – 8:00 PM Saturday – Sunday 9:00 AM – 11:00 AM 1:00 PM- 3:00 PM

To ensure enough time the facility recommends you check in by 10:30 AM, 2:30 PM, and 7:30 respectively. All visitors must be prepared to show a valid ID and visits are not to exceed 60 minutes.

Attorneys can visit clients seven days a week from 8:00 AM - 4:00 PM (including holidays).

Immigration Bond Information for the Buffalo Federal Detention Facility

Delivery bonds (i.e., immigration bonds) can be posted in-person directly at the Buffalo Federal Detention Facility. Immigration bonds can be posted Monday-Friday (except holidays) at this facility from 9:00 AM to 3:00 PM.

To post an immigration bond for someone detained at this facility you must have a money order, cashier's check or certified check. If the bond amount exceeds \$10,000 and over, you can only pay by single cashier's check or a certified check. All payments should be made to the "US Department of Homeland Security" or "Immigration and Customs Enforcement."

If you do not want to post the bond in-person yourself, you can also have a licensed immigration bond agent post the bond for you. For a small fee, ranging from 2% - 10%, an agent can post the bond for you electronically, so that you do not have to travel to the ICE ERO facility. This process is typically faster and easier than posting a bond yourself.

- First name
- Last name (including hyphenated last names)
- Any aliases the detainee might use
- Date of birth
- Country of birth

How to get in touch with an ICE detainee

Please have the following detainee information available:

- Full name
- Alien Registration Number (A Number)
- Your name and telephone number

Frequently asked questions about the Buffalo Federal Detention Facility

Does the facility have public parking?

Yes. If you know someone who is detained at Buffalo Federal Detention Facility in Batavia, New York and you would like to visit them, there is free parking at the facility.

Can I post a bond for someone who is detained at this facility?

If an immigration judge has set a bond in the immigrant's case, then yes, you may bond someone out of the Buffalo Federal Detention Facility. Unlike many other ICE Detention Centers, Buffalo Federal Detention Facility is an ICE-ERO facility, which means that you can post an immigration bond directly at this facility.

If I am bonding someone out of this facility, do I post the bond there or another location?

Delivery bonds (i.e., immigration bonds) can be posted in-person directly at the Buffalo Federal Detention Facility. Immigration bonds can be posted Monday-Friday (except holidays) at this facility from 9:00 AM to 3:00 PM. There are also three other ICE-ERO facilities in New York where you can post a bond. They are located at 130 Delaware Avenue, Buffalo, NY 14202, (716) 464-5800; 1086 Troy-Schenectady Road, Latham, NY 12110, (518) 220-2185; and 26 Federal Plaza, Room 9-110, New York, NY 10278, (212) 264-4280.

New York ICE Detention Facilities

There are seven ICE immigration detention facility in New York.

- Buffalo Federal Detention Facility
- Orange County Correctional Facility
- Albany County Correctional Facility
- Allegany County Jail
- Chautauqua County Jail
- Clinton County Jail
- Wayne County Jail

Not every detention facility allows you to post an immigration bond in New York. If you would like to post an immigration bond in New York it must be done at an ICE-ERO facility that accepts immigration bonds. In New York there are two ICE-ERO facilities where you can post an immigration bond in person. These facilities are at:

If you need an easier way to post an immigration bond for someone who is detained at an immigration detention facility, you can post an immigration bond through a licensed immigration bonding agent by calling (844) 910-2342. That agent can post a bond for you electronically for any detention facility in the US.
