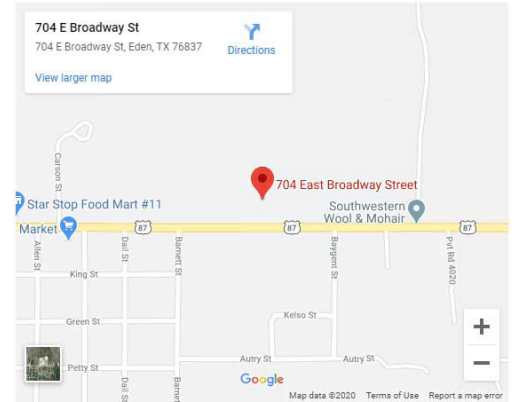

Immigration Bond Information for the Eden Detention Center

Delivery bonds (i.e., immigration bonds) cannot be posted in-person directly at the Montgomery Processing Center. Instead, family members or associates can post an immigration bond at any of the 82 ICE-ERO facilities around the country that accept immigration bonds. The closest facility to the Montgomery Processing Center that accepts immigration bonds is located at 126 Northpoint Drive, Bond Duty Window, Houston, TX 77060. The number there is (281) 774-4815. Immigration bonds can be posted Monday-Friday (except holidays) at this facility from 9:00 AM to 3:00 PM. Bonds cannot be posted directly at the Montgomery Processing Center.

To post an immigration bond for someone detained at this facility you must have a money order, cashier's check or certified check. If the bond amount exceeds \$10,000 and over, you can only pay by single cashier's check or a certified check. All payments should be made to the "US Department of Homeland Security" or "Immigration and Customs Enforcement."

If you do not want to post the bond in-person yourself, you can also have a licensed immigration bond agent post the bond for you. For a small fee, ranging from 2% – 10%, an agent can post the bond for you electronically, so that you do not have to travel to the ICE ERO facility. This process is typically faster and easier than posting a bond yourself.

How to get information on an ICE detainee

- Any aliases the detainee might use
- Date of birth
- Country of birth

- Alien Registration Number (A Number)
- Your name and telephone number

Frequently asked questions about the Eden Detention Center

Does the facility have public parking?

Yes. If you know someone who is detained at Montgomery Processing Center in Conroe, Texas and you would like to visit them, there is free parking available at the facility.

Can I post a bond for someone who is detained at this facility?

If an immigration judge has set a bond in the immigrant's case, then yes, you may bond someone out of this facility. See the next question below, regarding the various locations where bonds can physically be posted and processed.

If I am bonding someone out of this facility, do I post the bond there or another location?

While you can bail someone out of the Montgomery Processing Center, you cannot post the bond at that facility. The immigration bond must be posted at one of 82 ICE-ERO facilities that accept immigration bonds. The closest facility to the Montgomery Processing Center that accepts immigration bonds is located at 126 Northpoint Drive, Bond Duty Window, Houston, TX 77060. The number there is (281) 774-4815.

Not every detention facility allows you to post an immigration bond in Texas. If you would like to post an immigration bond in Texas it must be done at an ICE-ERO facility that accepts immigration bonds. In Texas there are eleven ICE-ERO facilities where you can post an immigration bond in person. These facilities are located at:
